For and on behalf of the Bangalore Water Supply and Sewerage Board, **PERCENTAGE/ITEMWAR TENDER** is invited through *e-procurement process* with tender procedure in line with Rule 28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (South-East), 4<sup>th</sup> block, Jayanagar, Bangalore-56011 for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

1. (1)Credit Card (Online Payment) 2) Direct Debit Using Internet Banking (Online Payment) 3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e-procurement.
5. The Tender processing fee once paid will not be refunded.
6. The Last date and time for Receipt of tenders will be on 28.04.2020 upto 16:00Hrs and the date of opening of tender will be on 30.04.2020 after 15.00Hrs.

The Eligibility criterion for the above works is as follows:

The tender is based on Two Cover System

1. Contractors should have be a Civil contractor and have contractor registration in BWSSB or KPWD/KUWSDB, etc Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
2. The Tenderer Should have in the last 5 years period achieved in at least two financial years an average annual financial turnover of rupees not less than the estimated cost (Profit and Loss Account, Balance Sheet certified, Audited by Chartered Accountant are mandatory).
3. The tenderer should have satisfactorily completed one similar work to an extent of 50% of the cost of the work in the last 5 years.
4. Assessed available tender capacity = ( A\*N\* 2.5 - B ) should be greater than the amount put to tender.

A = Maximum value of civil engineering works executed in any one year during the last five years taking into account the completed as well as works in progress.

N = Numbers of years

B = Value of on going works

5. The contractor should have satisfactorily completed (at least 80% of the contract value) as prime contractor should have executed for a continuous period one year, ,
6. Liquid assets or availability of credit facilities should be 30% of the amount of contract .
7. Form of tender is mandatory to be uploaded in e-procurement portal.
8. Refer Annexure (A) enclosed along for jurisdiction of the courts and safety measures to be taken while executing the works as per letter No. BWSSB/EIC/CE(P)/0027/16-17 Dt: 10.04.2017 & further hereby informed to include the same in the contract agreement Applications / requisitions from joint venture Firms are not acceptable.
10. Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.

13. Bidders shall submit offers that comply with the requirements of the bid document, including the basic technical design as indicated in the drawing and specifications. Alternatives will not be considered. The attention of the bidders is drawn to clause 23 regarding the rejection of the bids, which are not substantially responsive to the requirement of the bid document.
