*For and on behalf of the Bangalore Water Supply and Sewerage Board, **SHORT TERM ITEMWAR TENDER 2<sup>ND</sup> CALL** is invited through e-procurement process with tender procedure in line with Rule 28 of the KTPP Act by the **Executive Engineer, Water Supply and Sanitary Division (East)-2, 10<sup>th</sup> main, 1<sup>st</sup> cross, Indiranagar 2<sup>nd</sup> Stage, Bangalore-560038** for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.*

*The Tenderers are required to pay the **Earnest Money Deposit only through e-procurement portal** only using any of the four modes.*

1. (1)Credit Card (Online Payment) (2) Direct Debit Using Internet Banking (Online Payment) (3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

- Contractors should have Civil contractor registration in BWSSB or KPWD/KUWSDB,etc Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
- Assessed available tender capacity should be  $(A*N*5.00-B)$  should be greater than the amount put to Tender.

A= Maximum value of Civil Engineering works executed in any one year during the last five years taking into account the completed as well as works in progress.

N = Number of years

B = Value of on-going works.

- The Form of tender as per the proforma available in KW-1 should be duly filled and uploaded in the e-procurement portal as a part of tender document which is mandatory.
- The Third Party will be nominated by BWSSB

  - Security deposit for an amount equivalent to 5% of the contract price shall be deducted in every running bill. However, 1<sup>st</sup> & Final bill, the entire security deposit will be deducted from the final bill.
  - **The Caste certificate & the Domicile certificate is mandatory to be uploaded in e-procurement portal as per G.O NO.FD 876 Exp-12/2017, Bangalore Dt:10.10.2017 & Letter No. ಸಂ.ಆ.ಇ 876(ಓ-1) ವೆಚ್ಚ-12/17 ದತೆ:12.10.2017**
  - Road cutting machine should be used mandatorily for cutting the approved width of road while executing the work as per Circular NO/BWSSB/CH/CAO-S/CHI/138/2019-20 Dt:4.9.2019
  - The rates quoted in the tender offer shall be by considering the current tax option.
  - All other conditions put forth as per KW-1 act shall be followed read with amendments vide G.O No.FD4PCL 2008 Bangalore Dt:14.10.2008

Within 20 Days of the receipt of the letter of acceptance, the successful tenderer shall deliver to the employer a Security deposit in any of the forms given below. **For an amount equivalent to 5% of the contract price plus additional security for unbalanced tenders in accordance with clause 25.5 of ITT & clause 44 of the conditions of contract for all works** from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified.
  8. Applications / requisitions from joint venture Firms are not acceptable.
  9. Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.
