2. The Executive Engineer, Waste Water Management-(Challaghatta) Division, BWSSB invites tenders from eligible tenderers registered in **e-Procurement Portal** with **Single Cover** tender procedure in line with the Rule 28 of the KTPP Act. The details regarding their capability to undertake the tender (as detailed in ITT Clause 3) and the price tender shall be uploaded in the website of the e-procurement. Technical & financial details will be opened on the date and time mentioned in ITT clause 15 and evaluated. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.
3. Tender documents can be viewed/downloaded through e-Procurement portal from **02/05/2020 to 08/05/2020 up to 16.00hrs.** Interested Tenderers may obtain further information at the address mentioned below.
4. The Bidders can download the E-procurement document using his user ID-Password, by accessing Karnataka Govt. website and by clicking on e-procurement portal which will link to **www.eproc.Karnataka.gov.in** where electronic tender form is provided. Additional information related to e-procurement process can be obtained through the above-mentioned website. The electronic tender comprising Technical and Financial bids will be operated as **Single Cover System.**
5. Tenders must be accompanied by Earnest Money Deposit specified for the work in the Tale below. Earnest Money Deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 45 days beyond the validity of the tender.

- Contractors should have registration in BWSSB or KPWD/KUWSDB, etc. Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
- **Assessed Available tender capacity (AxNx2.5-B)>25.52lakhs in KW-2** should be greater than the amount put to tender is mandatory to be uploaded in e-procurement portal.
- The **Form of tender** as per the proforma available in **KW-2** should be duly filled and uploaded in the tender wizard as a part of tender document which is mandatory.

5. The last date for submission of completed tender document is 08.05.2020 **up to 16:00 hrs.** The bids will be opened on 11.05.2020 at **11.00 Hrs.** If the bid-opening day remains as public holiday, Bids will be opened on the next working day at the original stipulated time.

6. EMD can be paid through OTC, NEFT, and DEBIT CARD & CREDIT CARD through e-Procurement only. The value of the Bid Security / EMD is as mentioned in the table above in column no 4.

7. Bidders can access tender documents from the website and upload the required details; those are mentioned in different sections in the bid document in to electronic tender box on the website. Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e- procurement in **PDF** format for clear vision.
8. The cost of the tender document once paid will not be refunded.
9. The successful bidder would be required to give **performance bank guarantee of 5%** of the contract amount **from a Nationalized / Scheduled Indian Bank**, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
10. Applications / requisitions from joint venture Firms are not acceptable.
11. Bangalore Water Supply and Sewerage Board reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.
