For and on behalf of the Bangalore Water Supply and Sewerage Board, Short term **PERCENTAGE/ITEMWAR TENDER** is invited through e-procurement process with tender procedure in line with Rule 28 of the KTCP Act by the Executive Engineer, Water Supply and Sanitary Division (North-East), 18th cross Malleswaram, Bangalore-56011 for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

Tenders will be opened on the date and time mentioned in ITT clause 5 and evaluated. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

The Eligibility criterion for the above works is as follows:


- The tender is based on Single Cover System

- Assessed Available Tender Capacity (A*N*2.5-B).
- Form of tender is mandatory to upload in e-procurement portal.

FM 1320 pipeline Extension

- The successful bidder would be required to give performance **bank guarantee of 5%** of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
- Applications / requisitions from joint venture Firms are not acceptable.
