For and on behalf of the Bangalore Water Supply and Sewerage Board is invited through e-procurement process with tender procedure in line with Rule 28 of the KTPP Act by the Executive Engineer, Waste Water Management Division(K&C), BWSSB, Kapila Bhavan, 2nd Floor, 4th 'T' Block, Jayanagar, Bangalore-560 041, for the following work from registered Agencies of appropriate class as indicated against each work of BWSSB/KUWSDB/KPWD, etc. who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

1. (1) Credit Card (Online Payment) (2) Direct Debit using Internet Banking (Online Payment) (3) Remittance at the Bank Counter – Challan (offline Payment) 4) NEFT (National Electronic Fund Transfer) (Offline payment) The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.
2. Tender documents may be downloaded from www.eproc.karnataka.gov.in website only. Interested tenderers may obtain further information at the same address.

Bidders can access tender documents from www.eproc.karnataka.gov.in website only and upload the required details; those are mentioned in different sections in the bid document in to electronic tender on the website. Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e-procurement.
5. The Tender processing fee once paid will not be refunded.
6. The last date and time for Receipt of tenders will be on 21/05/2020 up to 16:00 Hrs and the date of opening of tender will be on 11-11-2019 after 16:05 Hrs.

The Eligibility criterion for the above work is as follows:

- The Tender is based on Single Cover System.
 - Contractors should have registration in BWSSB or KPWD/KUWSDB, etc. Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
 - **Assessed Available tender capacity (AxNx2.5-B) in KW-2** should be greater than the amount put to tender is mandatory to be uploaded in e-procurement portal.
 - The **Form of tender** as per the proforma available in **KW-2** should be duly filled and uploaded in the tender wizard as a part of tender document which is mandatory.
 - The bidder should have average annual turnover (in all classes of Civil Engineering construction works) of **Rs.37.35 lakhs** for any of the two financial year during the last five years (2015-16 to 2019-20).
 - The bidder should have satisfactorily completed one similar work of 450mm dia & above to an extend of **Rs.18.68 lakhs** in any year during the last five years (2015-16 to 2019-20).
7. The Successful bidder would be required to give performance bank guarantee of 5% of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
 8. Applications / requisitions from joint venture firms are not acceptable.
 9. Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.

11. List of documents to support qualification of bidder is to be uploaded to the e-procurement website www.eproc.karnataka.gov.in.
12. Bidders shall submit offers that comply with the requirements of the bid document, including the basic technical design as indicated in the drawing and specifications. Alternatives will not be considered. The attention of the bidders is drawn to clause 23 regarding the rejection of the bids, which are not substantially responsive to the requirement of the bid document.
