For and on behalf of the Bangalore Water Supply and Sewerage Board, **ITEMWARE/ PERCENTAGE TENDER** is invited through **e-procurement process** with tender procedure in line with Rule 28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (South), 4th block, Jayanagar, Bangalore-560011 for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

- (1) Credit Card (Online Payment) 2) Direct Debit Using Internet Banking (Online Payment) 3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e- procurement.
- The Tender processing fee once paid will not be refunded.
- The Last date and time for Receipt of tenders will be on 26.05.2020 16:00Hrs and the date of opening of tender will be on 28.05.2020 after 16.30Hrs.

The Eligibility criterion for the above works is as follows:

- The tender is based on Single Cover System
- Contractors should have Civil contractor registration in BWSSB or KPWD/KUWSDB, etc Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
- Assessed available tender capacity ($A*N*2.5-B$) should be greater than the amount put to tender
 A = Maximum value of civil engineering works executed in any one year during the last five years taking into account the completed as well as works in progress.
 N = Numbers of years
 B = Value of on going works
- Form of tender is mandatory to be uploaded in 'e' procurement portal.
- The rates quoted in the tender offer shall be by considering the benefits of concession rate of Central sales Tax (For all interstate procurement of materials only) as per section *(1) of the CST Act, 1956. Necessary Form 'C' will be issued by Board.
- The rates quoted should be inclusive of Third party inspection charges & applicable taxes that will be recovered from the bills. Third party will be nominated by BWSSB.
- The successful bidder would be required to give performance **bank guarantee of 5%** of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
- Applications / requisitions from joint venture Firms are not acceptable.
- Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.
