For and on behalf of the Bangalore Water Supply and Sewerage Board, Short term ITEMWAR TENDER is invited through e-procurement process with tender procedure in line with Rule 28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (South-West), 4th block, Jayanagar, Bangalore-56011 for the following work from registered Agencies of appropriate class as indicated against each work of BWSSB/KUWSDB/KPWD, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid GST registration, The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

1. (1)Credit Card (Online Payment) (2) Direct Debit Using Internet Banking (Online Payment) (3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (National Electronic fund transfer) (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in IFT clause 6 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.
2. Tender documents may be downloaded from www.eproc.karnataka.gov.in website only. Interested tenderers may obtain further information at the same address.
3. Additional information related to e-procurement process can be obtained through the above mentioned website or contact e-procurement helpdesk No.080-2550 1216 / 2550 1227. The electronic tender comprising Technical and Financial bids will be operated as **Single Stage Tender system**.
4. Bidders can access tender documents from www.eproc.karnataka.gov.in website only and upload the required details; those are mentioned in different sections in the bid document in to electronic tender on the website. Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e- procurement.
5. The Tender processing fee once paid will not be refunded.
6. The Last date and time for Receipt of tenders will be on **18.04.2020** upto 16:00Hrs and the date of opening of tender will be on **20.04.2020** after 15.00 Hrs.

- The Tenderer Should have a in the last 5 years period achieved in atleast two financial years an average annual financial turnover of rupees not less than estimated cost.
- The Tenderer should have satisfactorily completed one similar work to an extent of 50% of the cost of the respective works.

 - Profit & Loss Statement certified by Chartered accounted for a minimum period of Two Years upload in E-Procurement portal
 - Existing commitments on going Works upload in E-Procurement portal

- The rates quoted shall be inclusive of GST & Third party will be nominated by BWSSB.
- The successful bidder would be required to give performance **bank guarantee of 5%** of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.

Eligibility criterion for the above works allotted SC/ST Category

- Contractors should have Civil Contractor registration in BWSSB or KPWD/KUWSDB,etc Those who do not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order
- Form of tender is mandatory to upload in e-procurement portal.

- The Tenderer Should have a in the last 5 years period achieved in atleast two financial years an average annual financial turnover of rupees not less than estimated cost.
- The Tenderer should have satisfactorily completed one similar work to an extent of 25% of the cost of the respective works.

 - Profit & Loss Statement certified by Chartered accounted for a minimum period of Two Years upload in E-Procurement portal
 - Existing commitments on going Works upload in E-Procurement portal
 - Works for which tenders already submitted upload in E-Procurement portal
 - ITR for a Minimum period of Two financial years upload in E-Procurement portal.

- Caste certificate & domicile certificate issued by State Govt of Karnataka as per G.O.No.FD876 Exp-12/17 dt: 15.09.2017 is mandatory to upload in e-procurement portal.
- Security Deposit for an amount equivalent to 5% of the contract price shall be deducted in every running bill. However, in case of First and final bill the entire security deposit will be deducted from the bill and also the successful bidder would be required to give additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
- If in two attempts of tender bidding process, Bidders belonging to Scheduled castes and Scheduled Tribes participate is not Qualified, under this rule, then these works shall be tendered as open category wherein all eligible bidders of General or Scheduled castes or Schedules tribes category can participate.
- If Contractor is the firm, then all the partners or members of the firm shall belong to the Schedule castes or Schedule Tribes as the case may be.
- The rates quoted shall be inclusive of GST & Third party will be nominated by BWSSB.

7. The tender is based on Single Cover System

8. Applications / requisitions from joint venture Firms are not acceptable.

9. Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.

11. List of documents to support qualification of bidder is to be uploaded to the e-procurement website www.eproc.karnataka.gov.in

12. Bidders shall submit offers that comply with the requirements of the bid document, including the basic technical design as indicated in the drawing and specifications. Alternatives will not be considered. The attention of the bidders is drawn to clause 23 regarding the rejection of the bids, which are not substantially responsive to the requirement of the bid document.

13. Other details can be seen in the tender documents.

14. The works to be executed in accordance with the contract documents and to carry out all the works as per the guidelines in the "Safety Manual for construction and maintenance of UGD Lines and septic tanks in Urban Areas -2013". Any lapses in following the safety guidelines, the contractor/agency/firm will be held solely responsible.

15. Cutting Road Surfaces for Pipe line trenches should be executed using machineries only.
