For and on behalf of the Bangalore Water Supply and Sewerage Board, **SHORT TERM PERCENTAGE TENDER** is invited through e-procurement process with tender procedure in line with Rule 28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (South-East-2), 35th cross, 11th main, 4th T block, Jayanagar, Bangalore-560041 for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the **Earnest Money Deposit only through e-procurement portal** only using any of the four modes.

- (1) Credit Card (Online Payment) (2) Direct Debit Using Internet Banking (Online Payment) (3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

- Bidders can access tender documents from www.eproc.karnataka.gov.in website only and upload the required details; those are mentioned in different sections in the bid document in to electronic tender on the website. Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e-procurement.
- The Tender processing fee once paid will not be refunded.
- **The Last date and time for Receipt of tenders will be on 30.05.2020 upto 16:00 Hrs and the date of opening of tender will be on 02.06.2020 after 16.30Hrs.**

The Eligibility criterion for the above works is as follows:

1. The tender is based on Single Cover System.
2. Contractors should have civil contractor registration in BWSSB or KPWD/KUWSDB, etc as per KTPP norms. Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order
3. Assessed available tender capacity = $(A*N*2.5-B)$ should be greater than the amount put to tender.

4. Form of tender is mandatory to upload in e-procurement portal
5. P & L certified by the Chartered accounted
6. The successful bidder would be required to give performance bank guarantee of 5% of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
7. Applications / requisitions from joint venture Firms are not acceptable.
8. Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.
9. For any additional information regarding the above tender, the firms who are interested to quote, may contact office of the undersigned at the office address given below on all working days during office hours (10:30hours to 17:00 hours).
10. List of documents to support qualification of bidder is to be uploaded to the e-procurement website www.eproc.karnataka.gov.in
11. Bidders shall submit offers that comply with the requirements of the bid document, including the basic technical design as indicated in the drawing and specifications. Alternatives will not be considered. The attention of the bidders is drawn to clause 23 regarding the rejection of the bids, which are not substantially responsive to the requirement of the bid document.
12. The Rates quoted in the tender offer shall be inclusive of GST.
13. As per GO No.FD55 Pro-Cell 2004, Bangalore Dt: 17.02.2005, the expenditure on the employment of the quality supervision consultants will be charged to the cost of works and goods and equipment's under procurement, also take action as per circular No. BWSSB/EIC/CE (M)/ACE (M)-I/DCE (M)-II/TA(M)-I/2012/17-18 dt:03.07.2017, further action will be taken to recover the cost of the above in the contract bills.
14. Other details can be seen in the tender documents.
15. The works are to be executed in accordance with the contract documents and to carry out all the works as per the guidelines in the "Draft Safety Manual for construction and maintenance of UGD Lines and septic tanks in Urban Areas -2013". Any lapses in following the safety guidelines, the contractor/agency/firm will be held solely responsible.
