For and on behalf of the Bangalore Water Supply and Sewerage Board, **SHORT TERM ITEMWAR TENDER – 2nd call is** invited through e-procurement process with tender procedure in line with Rule 28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (South-East), 10th main, 1st cross, Indiranagara, 2nd Stage, Bangalore-560038 for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the **Earnest Money Deposit only through e-procurement portal** only using any of the four modes.

1. (1)Credit Card (Online Payment) (2) Direct Debit Using Internet Banking (Online Payment) (3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.
2. Tender documents may be downloaded from www.eproc.karnataka.gov.in website only. Interested tenderers may obtain further information at the same address.

comprising Technical and Financial bids will be operated as Single stage Tender system.

4. Bidders can access tender documents from www.eproc.karnataka.gov.in website only and upload the required details; those are mentioned in different sections in the bid document in to electronic tender on the website. Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e-procurement.
5. The Tender processing fee once paid will not be refunded.
6. The Last date and time for Receipt of tenders will be on **04.06.2020 upto 16:00 Hrs and** the date of opening of tender will be on **05.06.2020 after 17.00Hrs.**

The Eligibility criterion for the above works is as follows:

- The tender is based on **TWO COVER System**
- Contractors should have registration in BWSSB or KPWD/KUWSDB, etc as per KTPP norms. Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.

- The tenderer should have achieved in at least two financial years an average annual financial turnover of rupees not less than the estimated cost under this contract (amount put to tender) **i.e., Rs.94.121 lakhs.** Turnover, Profit & Loss account, Balance sheet statement certified / audited by Chartered Accountant to be submitted.
 - The tenderer should have satisfactorily completed one similar work to an extent of 50% of the cost of this work (amount put to tender) ie. **Rs.47.13 lakhs.**
 - Satisfactorily should complete (at least 80% of the contract value), as prime contractor, at least one similar work such as providing and laying of 400mm dia RCC NP3 class pipe line along with construction of new manholes for a length of **767.68 Rmt** in a continuous 12 months respectively.
 - Liquid assets or availability of credit facilities usually 30% of the amount of contract of **Rs.28.28 lakhs** (30% of contract valve cost).
 - Assessed available tender capacity = **(A*N*2.5)-B**
Where, **A**= Maximum value of Civil Engineering works executed in any one year during the last five years taking into account the completed as well as works in progress
N = Number of years &
B = Value of on-going works
 - **Form of tender** is mandatory to upload in e-procurement portal and the rates should not be disclosed.
 - Each tenderer should further demonstrate (a) availability by owing at least 50% of the required/specified key & critical equipment for this work and (b) the remaining 50% can be deployed on lease / hire basis for all works provided, the relevant documents (commitment agreements etc.,) for availability for this work are to be furnished.
7. Within 20 Days of the receipt of the letter of acceptance, the successful tenderer shall deliver to the employer a Security deposit in any of the forms given below. **For an amount equivalent to 5% of the contract price plus additional security for unbalanced tenders in accordance with clause 25.5 of ITT & clause 44 of the conditions of contract for all works** from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified.
 8. Applications / requisitions from joint venture Firms are not acceptable.
 9. Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.
