For and on behalf of the Bangalore Water Supply and Sewerage Board, **SHORT TERM TENDERS** are invited through e-procurement process with tender procedure in line with Rule-28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (South-East)-1, 10th main, 1st cross, Indiranagara, 2nd stage, Bangalore-560038 for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB / KUWSDB / KPWD** etc., who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

*The tenderers are required to pay the **Earnest Money Deposit** only through e-procurement portal only using any of the four modes.*

1. (1)Credit Card (Online Payment) (2) Direct Debit Using Internet Banking (Online Payment) (3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e- procurement.

6. The Last date and time for Receipt of tenders will be on 10.06.2020 upto 16:00 Hrs and the date of opening of tender will be on 11.06.2020 after 10.00 Hrs.

N = Number of years
B = Value of on-going works.

For an amount equivalent to 5% of the contract price **plus additional security for unbalanced tenders in accordance with clause 25.5 of ITT & clause 44 of the conditions of contract** for all works from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified.
