For and on behalf of the Bangalore Water Supply and Sewerage Board, **SHORT TERM TENDERS** are invited through e-procurement process with tender procedure in line with Rule-28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (South-East)-1, 10th main, 1st cross, Indiranagara, 2nd stage, Bangalore-560038 for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB / KUWSDB / KPWD** etc., who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

*The tenderers are required to pay the **Earnest Money Deposit** only through e-procurement portal only using any of the four modes.*

1. (1)Credit Card (Online Payment) (2) Direct Debit Using Internet Banking (Online Payment) (3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.
2. Tender documents may be downloaded from www.eproc.karnataka.gov.in website only. Interested tenderers may obtain further information at the same address.

4. Bidders can access tender documents from www.eproc.karnataka.gov.in website only and upload the required details; those are mentioned in different sections in the bid document in to electronic tender on the website. Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e- procurement.
5. The Tender processing fee once paid will not be refunded.

6. The Last date and time for Receipt of tenders will be on 11.06.2020 upto 16:00 Hrs and the date of opening of tender will be on 12.06.2020 after 17.00 Hrs.

 - Contractors should have registration in BWSSB or KPWD/KUWSDB, etc as per KTPP act. Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
 - For Other category Assessed available tender capacity should be $(A*N*2.5)-B$ are greater than the amount put to tender respectively, where,
A= Maximum value of Civil Engineering works executed in any one year during the last five years taking into account the completed as well as works in progress
N = Number of years
B = Value of on-going works.
 - Applications / requisitions from joint venture Firms are not acceptable.
 - Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.
 - For any additional information regarding the above tender, the firms who are interested to quote, may contact office of the undersigned at the office address given below on all working days during office hours (10:30 hours to 17:00 hours)
 - Caste certificate should be uploaded in the e-procurement portal issued from the concerned Authority for authentication at the time of bidding
 - The tenderer / contractor belonging to the SC/ST shall be domicile of the State of Karnataka for more than 10 years and for the same certificate / document should be uploaded.
 - List of documents to support qualification of bidder is to be uploaded to the e-procurement website www.eproc.karnataka.gov.in
 - All other conditions put forth as per KW-1, KW-2 & KW-3 of KTPP act shall be followed read with amendments vide G.O No.FD4PCL 2008 Bangalore Dt:14.10.2008 & No.FD876(P-1)Exp-12/2017, Bangalore dt.12.10.2017.
 - For the above list of tenders, **the conditions are applicable as per respective KTPP Act and the same will be published at the time of uploading the tenders in e-procurement portal.**
 - Other details can be seen in the tender documents.
7. Within 20 Days of the receipt of the letter of acceptance, the successful tenderer shall deliver to the employer a Security deposit in any of the forms given below. For an amount equivalent to 5% of the contract price **plus additional security for unbalanced tenders in accordance with clause 25.5 of ITT** & clause 44 of the conditions of contract for all works from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified and for SC/ST Category the Security Deposit for an amount equivalent to 5% of the contract price shall be deducted in every running bill. However, in case of first and final bill, the entire security deposit will be deducted from the final bill.
