For and on behalf of the Bangalore Water Supply and Sewerage Board, Bangalore **tender** is invited through e-procurement process with tender procedure in line with Rule 28 of the K.T.P.P Act by the Executive Engineer, Central Division, High Ground, Miller Road, Bangalore-52 for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

1. Credit Card (Online Payment) 2) Direct Debit Using Internet Banking (Online Payment) 3) Remittance at the Bank Counter - Challan (Offline Payment) 4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

- The above tenders are Single Cover System.
- Bidders have to visit the site to acquaint about the ground conditions before bidding.
- Contractors should be a Civil Contractor and have contractor registration in BWSSB or KPWD/KUWSDB, etc. Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
- Assessed available tender capacity = $(A * N * 2.5 - B)$ should be greater than the amount put to tender.
A = Maximum value of civil engineering works executed in any one year during the last five years taking into account the completed as well as works in progress.
N = Number of years
B = Value of on-going works.
- The form of tender as per the proforma available in KW-1 should be duly filled and uploaded which is mandatory.
Note: Road cutting machine should be used mandatorily for cutting the approved width of road while executing the work as per circular No. BWSSB/CH/CAO-s/CH/138/19-20 dt:4.9.2019
- 7. Applications / requisitions from joint venture Firms are not acceptable.
- 8. The successful bidder would be required to give performance bank guarantee of 5% of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
- 9. Applications / requisitions from joint venture Firms are not acceptable.
- 10. Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.

The attention of the bidders is drawn to clause 27 regarding the rejection of the bids, which are not substantially responsive to the requirement of the bid document.
