For and on behalf of the Bangalore Water Supply and Sewerage Board, **ITEMWAR TENDER** is invited through e-procurement process with tender procedure online with Rule 28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (North), Pinakini Bhavan, Doddaballapur Road, Yelahanka New Town. Bangalore-560055 for the work of Providing and laying 230 mm dia SW line/ 300mm Dia RCC NP-3 Pipe line at Mariyamma Block coming under Ward 11 of AEEN-3 Sub division from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

1. (1)Credit Card (Online Payment) 2) Direct Debit Using Internet Banking (Online Payment) 3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the tender shall be uploaded in the website. Tenders will be opened on the date and time mentioned in ITT clause 5 and evaluated. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.
2. Short Term Tender documents may be downloaded from www.eproc.karnataka.gov.in website only. Interested tenderers may obtain further information at the same address.

4. Bidders can access Short Term tender documents from www.eproc.karnataka.gov.in website only and upload the required details; those are mentioned in different sections in the bid document in to electronic tender on the website. Scanned documents those are

required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e- procurement.

5. The Tender processing fee once paid will not be refunded.
6. The Last date and time for Receipt of tenders will be on 18.06.2020 upto 17.00 Hrs **and the date of opening of tender will be on 19.06.2020 after 17.15 Hrs.**

The Eligibility criterion for the above works is as follows:

- The tender is based on Two Cover System
- Contractors should have registration in BWSSB or KPWD / KUWSDB, etc Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
- The Tenderer Should have in the last 5 years period achieved in at least two financial years an average annual financial turn over of rupees not less than the estimated cost under this contract i.e Rs.67.71 lakhs
- The tenderer should have satisfactorily completed one similar work to an extent of 50% of the cost of the work. i.e Rs.33.86 lakhs .
- Liquid assets and or availability of credit facilities usually 30% of the amount of contract i.e 20.32 lakhs.
- The tenderer should have executed in any one year the following minimum quantities of works usually 80% of the annual requirement i.e 300 mm dia RCC - 374 rmt, OR Higher dia and length.
- Assessed Available tender capacity (A*N*2.5-B).
- Each tenderer should further demonstrate (a) availability by owning at least 50% of the required / specified key and critical equipment for this work and (b) the remaining 50% can be deployed on lease/hire basis for all works provided, the relevant documents (commitment agreements etc) for availability for this work are to be furnished especially for the Crane.

- Liquid assets and /or availability of credit facilities of no less than Rs. 20.32 lakhs credit lines/ letter of credit/certificates from banks for meeting the fund requirement etc.(usually the equivalent of the estimated cash flow for three months in the peak construction period)
- The successful bidder would be required to give performance **bank guarantee of 5%** of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
- Refer Annexure (A) enclosed along for jurisdictions of the courts and safety measures to be taken while executing the works as per letter No.BWSSB/EIC/CE(P)/0027/16-17 dt:10.04.2017.
- Applications / requisitions from joint venture Firms are not acceptable.
- Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.
