*For and on behalf of the Bangalore Water Supply and Sewerage Board, **ITEMWAR TENDER (4th CALL)** IS invited through e-procurement process with tender procedure in line with Rule 28 of the KTPP Act by the **Executive Engineer, Water Supply and Sanitary Division (East)-1, 10th main, 1st cross, Indiranagar 2nd Stage, Bangalore-560038** for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.*

*The Tenderers are required to pay the **Earnest Money Deposit only** through e-procurement portal only using any of the four modes.*

1. (1)Credit Card (Online Payment) (2) Direct Debit Using Internet Banking (Online Payment) (3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

Bidders can access tender documents from www.eproc.karnataka.gov.in website only and upload the required details; those are mentioned in different sections in the bid document in to electronic tender on the website. Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e- procurement.

5. The Tender processing fee once paid will not be refunded.

6. The Last date and time for Receipt of tenders will be on **13.07.2020** upto **16:00 Hrs** and the **date of opening of tender** will be on **15.07.2020** after **17.00Hrs**.

The Eligibility criterion for the above works is as follows:

- The tenders is based on SINGLE STAGE System
- Contractors should have Civil contractor registration in BWSSB or KPWD/KUWSDB,etc Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
- The Tenderer should have in the last 5 years period achieved in atleast **Two Financial years** an average annual **Financial turnover** of Rupees not less than **Rs.35.67 Lakhs** [**Profit & Loss account, Balance Sheet Certified , Audited by Chartered Accountant** are mandatory).
- The Tenderer should have satisfactorily completed one similar work to an extent of **Rs.17.84 Lakhs**.
- Assessed available tender capacity should be $(A*N*2.5-B)$ should be greater than the amount put to Tender.

A= Maximum value of Civil Engineering works executed in any one year during the last five years taking into account the completed as well as works in progress.

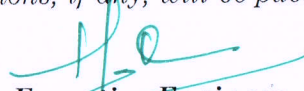

B = Value of on-going works.

- The Form of tender as per the proforma available in KW-2 should be duly filled and uploaded in the e-procurement portal as a part of tender document which is mandatory.
 - The Third Party will be nominated by BWSSB
 - Road cutting machine should be used mandatorily for cutting the approved width of road while executing the work as per Circular NO/BWSSB/CH/CAO-S/CHI/138/2019-20 Dt:4.9.2019
 - The rates quoted in the tender offer shall be by considering the current tax option.
 - All other conditions put forth as per KW-II of KTPP act shall be followed read with amendments vide G.O No.FD4PCL 2008 Bangalore Dt:14.10.2008 & GO No.FD 876 Exp-12/2017, Bangalore Dt:10.10.2017
 - As per GO No.FD55 Pro-Cell 2004, Bangalore Dt:17.2.2005, the expenditure on the employment of the quality supervision consultants shall be charged to the cost of the works and goods & equipment under procurement. As per circular No.BWSSB/EIC/CE(M)/ACE(M)-I/DCE(M)-II/TA(M)-I/2012/Dt:3.7.2017, action will be taken to recover the cost of the above in the Contract bills.
 - The contractor shall be liable & agree to the Amendment to the Contacts (Amendment No.1) i.e regarding Jurisdiction of the Courts & Safety measures to be taken while executing the works
7. Within 20 Days of the receipt of the letter of acceptance, the successful tenderer shall deliver to the employer a Security deposit in any of the forms given below. **For an amount equivalent to 5% of the contract price plus additional security for unbalanced tenders in accordance with clause 25.5 of ITT & clause 44 of the conditions of contract for all works** from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified.
 8. Applications / requisitions from joint venture Firms are not acceptable.
 9. Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.
