INVITATION FOR TENDER

The **Chief Engineer(Waste Water Management)** invites tenders from eligible tenderers for the Estimate for the work of Biological Nutrient Removal process at 248 MLD STP at K& C Valley detailed in the table below. Tenderers are requested to submit their tender, EMD and details of their capability to undertake the tender (as detailed in ITT Clause-3 & 6) in the Karnataka e-Procurement Portal. Price tender will be opened only if the Tenderer is found to be qualified to execute the tendered works. Tenderers are advised to note the minimum qualification criteria specified in clause 3 of the Instructions to Tenderers to qualify for award of the contract.
2. Tender documents may be downloaded through e-Procurement Portal www.eproc.karnataka.gov.in website only from **03.08.2020 to 17.08.2020**. Interested Tenderers may obtain further information by accessing the same website.
3. Tenders must be accompanied by Earnest Money Deposit specified for the work in the Table below. EMD will have to be in any one of the forms as specified in the Tender document and shall have to be valid for **45**days beyond the validity of the tender.
4. The last date and time for receipt of tenders in the Electronic Tender Box in website (www.eproc.karnataka.gov.in) is **17.08.2020 up to 17:30 hrs**. The technical bids will be opened **on 19.08.2020 at 16:00hrs**. If the bid-opening day remains as public holiday, bids will be opened on the next working day at the original stipulated time.

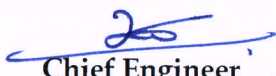

9. The successful Tenderer would be required to furnish the performance Bank Guarantee from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period as mentioned in tender document.
