The **Chief Engineer(Waste Water Management)** invites tenders from eligible tenderers for the Tender for the Work of Providing and Laying 700mm Dia NP-3 class RCC Sewer pipeline from Shettihalli Tank to Madrahalli ISPS detailed in the table below. Tenderers are requested to submit their tender, EMD and details of their capability to undertake the tender (as detailed in ITT Clause-3 & 6) in the Karnataka e-Procurement Portal. Price tender will be opened only if the Tenderer is found to be qualified to execute the tendered works. Tenderers are advised to note the minimum qualification criteria specified in clause 3 of the Instructions to Tenderers to qualify for award of the contract.
2. Tender documents may be downloaded through e-Procurement Portal [www.eproc.karnataka.gov.in](http://www.eproc.karnataka.gov.in) website only from 10.08.2020 to 08.09.2020. Interested Tenderers may obtain further information by accessing the same website.
3. Tenders must be accompanied by Earnest Money Deposit specified for the work in the Table below. EMD will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 45 days beyond the validity of the tender.
4. The last date and time for receipt of tenders in the Electronic Tender Box in website ([www.eproc.karnataka.gov.in](http://www.eproc.karnataka.gov.in)) is 08.09.2020 up to 17:30 hrs. The technical bids will be opened on 10.09.2020 at 16:00hrs. If the bid-opening day remains as public holiday, bids will be opened on the next working day at the original stipulated time.
