For and on behalf of the Bangalore Water Supply and Sewerage Board, Short term **ITEMWAR TENDER** is invited through e-procurement process with tender procedure in by the Executive Engineer, Water Supply and Sanitary Division (South), 4th block, Jayanagar, Bangalore-560011 for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid GST registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

1. (1)Credit Card (Online Payment) 2) Direct Debit Using Internet Banking (Online Payment) 3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.
2. Tender documents may be downloaded from www.eproc.karnataka.gov.in website only. Interested tenderers may obtain further information at the same address.

4. Bidders can access tender documents from www.eproc.karnataka.gov.in website only and upload the required details; those are mentioned in different sections in the bid document in to electronic tender on the website. Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e- procurement.
5. The Tender processing fee once paid will not be refunded.
6. The Last date and time for Receipt of tenders will be on 15-9-20 up to 16:00Hrs and the date of opening of tender will be on 18-9-20 after 16.30Hrs.

The Eligibility criterion for the above works allotted for others Category is as follows:

- Contractors should have be a Civil contractor registration in BWSSB or KPWD/KUWSDB, etc Those who do not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Orders.
 - Form of tender is mandatory to be uploaded in e-procurement portal.
 - Assessed available tender capacity = (A*N* 2.5 - B) should be greater than the amount put to tender.
 - The Tenderer Should have in the last 5 years period achieved in atleast two financial years an average annual financial turnover of rupees not less than the estimated cost .
 - The tenderer should have satisfactorily completed one similar work to an extent of 50% of the cost of the respective work
 - **Qualification Information : As per DTP**
 - e) Profit and Loss Statement certified by Chartered Accounted for a minimum period of Two Years upload in E-Procurement portal
 - f) Existing commitments on going works upload in E - Procurement portal
 - g) Works for which tenders already submitted upload in E-Procurement portal
 - h) ITR for a Minimum period of Two financial years upload in E-Procurement portal
 - The rates quoted shall be inclusive of GST & Third party will be nominated by BWSSB.
 - The successful bidder would be required to give performance **bank guarantee of 5%** of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
7. The tender is based on Single Cover System
 8. Applications / requisitions from joint venture Firms are not acceptable.
 9. Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.

12. Bidders shall submit offers that comply with the requirements of the bid document, including the basic technical design as indicated in the drawing and specifications. Alternatives will not be considered. The attention of the bidders is drawn to clause 23 regarding the rejection of the bids, which are not substantially responsive to the requirement of the bid document.

14. The works to be executed in accordance with the contract documents and to carry out all the works as per the guidelines in the "Safety Manual for construction and maintenance of UGD lines and septic tanks in Urban Areas - 2013". Any lapses in following the safety guidelines, the contractor/agency /firm will be held solely responsible.
15. Cutting Road Surfaces for pipe line trenches should be executed using machineries only.
