**INVITATION FOR TENDER (IFT)**

1. The **Chief Engineer (K)** invites tender from eligible tenderers, for the work of **construction of bitumen macadam road from NBR to T.K.Halli** through e-procurement process with two stages tender procedure in line with the Rule 28 of the KTPP Act. The details regarding their qualification to take the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website of the e-procurement portal. Technical details will be opened on the date and time mentioned in IFT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 4 of the Instructions to Tenderers (ITT) to qualify for award of the contract.
2. Tender documents may be downloaded through the e-procurement portal which will link to [www.eproc.karnataka.gov.in](http://www.eproc.karnataka.gov.in) from 15.09.2020 to 13.11.2020 **upto 15.00 hrs**, on payment of a non-refundable fee indicated in the Table below, using any of these forms of OTC, NEFT, DEBIT CARD and CREDIT CARD through e-portal only. Interested tenderers may obtain further information at the Office of e-procurement. Tenderers will be issued a password and authorized for accessing the tender document in the website with URL: [www.eproc.karnataka.gov.in](http://www.eproc.karnataka.gov.in)
3. The Bidders can download the tender document using their user ID & password, by accessing [www.eproc.karnataka.gov.in](http://www.eproc.karnataka.gov.in) where electronic tender form is provided. Additional information related to e-procurement process can be obtained through the above mentioned website. The electronic tender will be operated as Two stage Tender system by opening the Technical details first and financial portion of the technically qualified tenderers later.
4. Tenders must furnish Earnest Money Deposit specified for the work in the Table below. Earnest Money Deposit will have to be paid through any one of the forms OTC, NEFT, DEBIT CARD and CREDIT CARD through e-portal only.

**I. General work experience: -**

i) The Tenderer as prime contractor should have satisfactorily completed during the last five years i.e., 2015-16 to 2019-20 at least one similar work to an extent of 50% of the cost of the work value not less than Rs.196.00lakhs (Construction of Bitumen Macadam Road).

ii) Executed in any one year, the following minimum quantities of work:

- a. Construction of wet mix macadam as per Morth V for a minimum quantity of 4200 Cum
- b. Construction of dense graded bituminous macadam layer as per Morth V for a minimum quantity of 1400Cum

**II. Financial capabilities: -**

a) To qualify for award of this contract, each tenderer in its name should have in the last five years i.e., 2015-16 to 2019-20 achieved in at least two financial years a minimum financial turnover (in all classes of civil engineering construction works) of Rs.783.00Lakhs

b) Liquid assets or availability of credit facilities of not less than Rs.118.00Lakhs for the above work (Credit Lines/Letter of credit/certificates from Nationalized/Scheduled banks in India for meeting the fund requirement etc.,)

c) Assessed available e-procurement tender capacity –  $(A*N*1.5-B)$  Should not be less than amount put to tender ie: Rs. 3,91,03,003/-

**where**

A = Maximum value of civil engineering works executed in any one year during the last five years (updated to **2019-20** price level) taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of the works for which tenders are invited.

B = Value, at **2019-20** price level, of existing commitments and on-going works to be completed during the next 6 Months.

Note: The statements showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Employer in charge, not below the rank of an Executive Engineer or equivalent.

**3. Equipment capacity : -**

Each tenderer should further demonstrate:

a) Availability by owning 100% any 2 (50% by owning plus 50% by hiring) of the required / specified key and critical equipment for this work, the relevant documents (Commitment agreements etc) for availability for this work shall be furnished. Some of the equipments are:

- i. **JCB** - 01 No.
- ii. **Single Drum Road Roller 120 TPH** – 01 No.
- iii. **Paver machine** - 01 No.
- iv **Tractor**– 01No



**4. Other conditions: -** a) Form of tender as per KW-4 of KTPP act to be uploaded by the Participated tenderer which is mandatory.

b) EMD amount to be paid as prescribed for the said tender.

5. The last date for uploading of completed tender document is on 13.11.2020 upto **15:00hrs.**
6. The Technical bids will be opened at the office mentioned in para no.12 on after **16:00 hrs** in the presence of bidders or their authorized representatives. If the bid opening day remains as public holiday, Bids will be opened on the next working day at the original stipulated time.
7. Bidders can access tender documents from the website and upload the required details; those are mentioned in different sections in the bid document in to electronic tender box on the website. Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e-portal preferably in **PDF** format for clear vision.
8. The cost of the tender document once paid will not be refunded.
9. The successful bidder would be required to give performance **Bank Guarantee of 5%** of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified in the clause no.29 of ITT, towards guarantee for completion of work within the stipulated period.
10. Applications / requisitions from joint venture Firms are not acceptable.
11. Bangalore Water Supply and Sewerage Board reserves the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.
