The electronic tender comprising Technical and Financial bids will be operated as **Single Cover System**.



6. EMD can be paid through OTC, NEFT, and DEBIT CARD & CREDIT CARD through E – Procurement only. The value of the Bid Security / EMD is as mentioned in the table above in column no 4.
7. Bidders can access tender documents from the website and upload the required details; those are mentioned in different sections in the bid document in to electronic tender box on the website. Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e- procurement in **PDF** format for clear vision.

The successful bidder would be required to give **performance bank guarantee of 5%** of the contract amount plus **additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, if the tenderer quoted amount is below amount put to tender** with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
