The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

(1) Credit Card (Online Payment) (2) Direct Debit using Internet Banking (Online Payment) (3) Remittance at the Bank Counter – Challan (offline Payment) 4) NEFT (National Electronic Fund Transfer) (Offline payment) The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

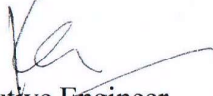
The Eligibility criterion for the above work is as follows:

- The Tender is based on Single Cover System.
 - Contractors should have registration in BWSSB or KPWD/KUWSDB, etc. Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
 - **Assessed Available tender capacity (AxNx2.5-B) in KW-1** should be greater than the amount put to tender is mandatory to be uploaded in e-procurement portal along with relevant document.
 - The **Form of tender** as per the proforma available in **KW-1** should be duly filled and uploaded in the tender wizard as a part of tender document which is mandatory.
7. The Successful bidder would be required to give performance bank guarantee of 5% of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
 8. Applications / requisitions from joint venture firms are not acceptable.
 9. Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.

Alternatives will not be considered. The attention of the bidders is drawn to clause 23 regarding the rejection of the bids, which are not substantially responsive to the requirement of the bid document.
