For and on behalf of the Bangalore Water Supply and Sewerage Board, **SHORT TERM TENDERS** are invited through e-procurement process with tender procedure in line with Rule-28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (South-East)-1, 10<sup>th</sup> main, 1<sup>st</sup> cross, Indiranagara, 2<sup>nd</sup> stage, Bangalore-560038 for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB / KUWSDB / KPWD** etc., who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

*The tenderers are required to pay the **Earnest Money Deposit** only through e-procurement portal only using any of the four modes.*

Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

- For Other category Assessed available tender capacity should be  $(A*N*2.5)$ -B and  $(A*N*5)$ -B (only for SC & ST category) are greater than the amount put to tender respectively, where,  
A= Maximum value of Civil Engineering works executed in any one year during the last five years taking into account the completed as well as works in progress  
N = Number of years  
B = Value of on-going works.
- Applications / requisitions from joint venture Firms are not acceptable.
- Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.

- Caste certificate should be uploaded in the e-procurement portal issued from the concerned Authority for authentication at the time of bidding\
- The tenderer / contractor belonging to the SC/ST shall be domicile of the State of Karnataka for more than 10 years and for the same certificate / document should be uploaded.

**additional security for unbalanced tenders in accordance with clause 25.5 of ITT & clause 44 of the conditions of contract for all works from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified and for SC/ST Category the Security Deposit for an amount equivalent to 5% of the contract price shall be deducted in every running bill. However, in case of first and final bill, the entire security deposit will be deducted from the final bill.**
