

The Tenders are required to submit their EMD, technical offer and financial offer and the details of their capability to undertake the tender (as detailed in ITT Clause 3 and section 2(a) and section (4) in Karnataka e-procurement portal. The price tender will be opened only if the Tenderer is found to be qualified to execute the tendered work. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.**
2. Tender documents can be view/download from e-Procurement portal from 07-12-2020 to 21-12-2020. Interested Tenderers may obtain further information at the address mentioned below.
