The Executive Engineer (MIS), invites item war tender from eligible tenderer for the work detailed in the Table below through E-Procurement process with two Covers tender procedure in line with the Rule 28 of the KTPP Act. The details regarding their qualification to take the tender (as detailed in ITT Clause 3 & 4) and the price tender shall be uploaded in the website of the e-procurement portal. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers (ITT) to qualify for award of the contract.
2. Tender documents may be downloaded through the e-procurement website www.eproc.karnataka.govt.in from Dt: 22.12.2021 to 06.01.2021 on payment of a non-refundable fee indicated in the Table below, using any of these forms of OTC, NEFT, DEBIT CARD and CREDIT CARD through e-procurement portal only. Interested Tenderers may obtain further information at the Office of e-procurement.
3. Tenders must be accompanied by Earnest Money Deposit(EMD) specified for the work in the Table below. Earnest Money Deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for **45 days** beyond the validity of the tender.
4. Tenders must be uploaded through e-procurement portal on or before 16.00 hours on Dt:06.01.2021 and First Cover Tenders will be opened on Dt: 08.01.2021 at 16.00 hours, in the presence of the tenderers who wish to attend. If the office happens to be closed on the date of receipt of the tenders as specified, the tenders will be opened on the next working day at the same time and venue.
5. The second cover tenders will be opened only for technically responsive tenderers on or after completion of technical evaluation of bids received.

Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e-portal (procurement) preferably in **PDF** format for clear vision.
10. The cost of the tender document once paid in e-procurement portal will not be refunded.

The successful bidder would be required to furnish performance **bank guarantee of 5%** of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified in the clause no.29 of ITT, towards guarantee for completion of work within the stipulated period.
12. Bangalore Water Supply and Sewerage Board reserve the right to cancel or annual the entire or part of this process of invitation at any time without assigning any reason.


