For and on behalf of the Bangalore Water Supply and Sewerage Board, **SHORT TERM TENDERS (1st CALL) IS** invited through e-procurement process with tender procedure in line with Rule 28 of the KTPP Act by the **Executive Engineer, Water Supply and Sanitary Division (East)-1, 10th main, 1st cross, Indiranagar 2nd Stage, Bangalore-560038** for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

1. (1)Credit Card (Online Payment) (2) Direct Debit Using Internet Banking (Online Payment) (3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

OTHER Conditions:-

- Road cutting machine should be used mandatorily for cutting the approved width of road while executing the work as per Circular NO/BWSSB/CH/CAO-S/CHI/138/2019-20 Dt:4.9.2019
- As per GO No.FD55 Pro-Cell 2004, Bangalore Dt:17.2.2005, the expenditure on the employment of the quality supervision consultants shall be charged to the cost of the works and goods & equipment under procurement. As per circular No.BWSSB/EIC/CE(M)/ACE(M)-I/DCE(M)-II/TA(M)-I/2012/Dt:3.7.2017, action will be taken to recover the cost of the above in the Contract bills.
- The contractor shall be liable & agree to the Amendment to the Contacts (Amendment No.1) i.e regarding Jurisdiction of the Courts & Safety measures to be taken while executing the works

Within 20 Days of the receipt of the letter of acceptance, the successful tenderer shall deliver to the employer a Security deposit in any of the forms given below. **For an amount equivalent to 5% of the contract price plus additional security for unbalanced tenders in accordance with clause 25.5 of ITT & clause 44 of the conditions of contract for all works** from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified.
