The Board keeps the right of acceptance or rejection of any tender without assigning any reasons. The tenderers may submit tenders for any or all of the works given in the Table. Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the Contract
2. The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.(1) Credit Card (Online Payment) (2) Direct Debit using Internet Banking (Online Payment) (3) Remittance at the Bank Counter – Challan (offline Payment) 4) NEFT (National Electronic Fund Transfer) (Offline payment) .The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

The Eligibility criterion for the above work is as follows:

- The Tender is based on Single Cover System.
  - Contractors should have registration in BWSSB or KPWD/KUWSDB, etc
  - The Tenderer should have a minimum average annual financial turnover of **Rs.32.70 lakhs** in at least two years in the last five years(2016-17-2019-20).
  - The tenderer should have satisfactorily completed at least one similar work such as **Supply,Erection and Commissioning of 30 Kw/ 40 HP Submersible sewage Pump (RAS) and filtrate pumps of 7.5 Kw/10 HP** to an extent of **Rs.16.35 lakhs** in the last five years.( i.e. 2016-17-2020-21)
  - The Form of tender as per the proforma available and Bid Capacity (  $A*N*2.5 - B$  ) should be greater than Rs.32,69,504/- (amount put to tender) in KW-2 should be duly filled and uploaded in the tender wizard as a part of tender document which is mandatory.
  - Before quoting the tender site shall be inspected.
- 7 The Successful bidder would be required to give performance bank guarantee of 5% of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
  - 8 Applications / requisitions from joint venture firms are not acceptable.
  - 9 Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.


