For and on behalf of the Bangalore Water Supply and Sewerage Board, **ITEMWARE/ PERCENTAGE TENDER is** invited through **e-procurement process** with tender procedure in line with Rule 28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (South), 4th block, Jayanagar, Bangalore-560011 for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

- (1)Credit Card (Online Payment) 2) Direct Debit Using Internet Banking (Online Payment) 3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT clause 5 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e-procurement.

1. The tender is based on Single Cover System
2. Contractors should have Civil contractor registration in BWSSB or KPWD/KUWSDB, etc Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
3. Assessed available tender capacity (A*N*2.5-B) should be greater than the amount put to tender
A = Maximum value of civil engineering works executed in any one year during the last five years
N = Numbers of years
B = Value of on going works
4. Form of tender is mandatory to be uploaded in 'e' procurement portal.
5. Refer Annexure (A) enclosed along for jurisdiction of the courts and safety measures to be taken while executing the works as per letter No. BWSSB/EIC/CE(P)/0027/16-17 Dt: 10.04.2017 & further hereby informed to include the same in the contract agreement.
6. The rates quoted in the tender offer shall be by considering the benefits of concession rate of Central sales Tax (For all interstate procurement of materials only) as per section *(1) of the CST Act, 1956. Necessary Form 'C' will be issued by Board.
7. The successful bidder would be required to give performance **bank guarantee of 5%** of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
8. Applications / requisitions from joint venture Firms are not acceptable.
9. Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.

11. List of documents to support qualification of bidder is to be uploaded to the e-procurement website www.eproc.karnataka.gov.in
12. Bidders shall submit offers that comply with the requirements of the bid document, including the basic technical design as indicated in the drawing and specifications. Alternatives will not be considered. The attention of the bidders is drawn to clause 23 regarding the rejection of the bids, which are not substantially responsive to the requirement of the bid document.
