The Executive Engineer (Cstr Division), Bangalore Water Supply & Sewerage Board, Bangalore-560 012 invites tenders through e-Procurement Portal from reputed Manufacturers/Authorized dealers of in two cover system (One for Technical Bid and the other for Financial bid) for Supply of 1261 Nos. of 25 mm dia Muttiget Class 'B' Magnetic type Water Meters conforming to IS:779/1944 OR ISO:4064/1 with its latest amendments with AMR compatibility. Only such tenderers who possess:-

- 1) IS:779/1944 OR ISO:4064/1/EEC/MID Certification for the Manufacture of the water meter.
- 2) Tenderer should furnish the recent Test report of 25mm dia water meters offered in the tender (April 2020 onwards) for tests having conducted and passed by FCRI as per IS:779/1944 OR ISO:4064/1 with its latest amendments.

- 3) a) The Tenderer should be a manufacturer who must have manufactured, and supplied the 1009 Nos of 25mm dia Muttiget Class B Magnetic Type water meters of the make (as per IS or ISO) in any one of the last three years (i.e. 2018-19 to 2020-21) OR

- b) As per Govt Order No.FD 908 Exp-12/2019 Bengaluru dt:21.07.2020 for Micro & Small Enterprises:-  
The tenderer should be a manufacturer who must have manufactured and supplied the 505 Nos of 25mm dia Muttiget Class B Magnetic Type water meters of the make (as per IS or ISO) in any one of the last three years (i.e. 2018-19 to 2020-21) OR

- c) Tenderers of tenderers quoting as authorized representative / agent/dealer of a manufacturer meeting with the above requirements in full, will also be considered provided;  
(i) The manufacturer's authorization should be furnished in the prescribed format assuring full guarantee and warranty obligations as per conditions of contract.

- (ii) The tenderer as authorized representative, should have supplied satisfactorily at least 379 Nos of 25mm dia Muttiget Class B Magnetic Type Water Meters of the make (as per IS or ISO) in any one of the last three years (i.e. 2018-19 to 2020-21).

- 4) a) The Tenderer shall possess an average financial Turn-Over of Rs. 74,38,639/- in atleast two financial years during the last five financial years, i.e., from 2016-17 to 2020-21. (Respective Balance sheets invariably attested by a Chartered Accountant are to be enclosed).

- (b) As per Govt Order No. FD 908 Exp-12/2019 Bengaluru dtd:21.07.2020 for Micro & Small Enterprises:-  
The Tenderer should possess an average annual financial turnover of the tenderer should be Rs.37,19,320/-  
in at least 2 preceding financial years during the last three years i.e., 2018-19 to 2020-21.
- (5) A Workshop with Test Bench facilities of their own in India are eligible to quote their offer.
