Bangalore-560055 for the work of Providing, laying and linking 450mm dia DI pipe line from GLR yelahanka to police station signal, Bellary road, Yelahanka coming under yelahanka new town S/s of AEEN-2 sub division from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

The Eligibility criterion for the above works is as follows:

- The tender is based on Two Cover System
- Contractors should have registration in BWSSB or KPWD / KUWSDB, etc Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
- The Tenderer Should have in the last 5 years period achieved in at least two financial years an average annual financial turn over of rupees not less than the estimated cost under this contract i.e Rs.86.52 lakhs
- The tenderer should have satisfactorily completed one similar work to an extent of 50% of the cost of the work. i.e Rs.43.26 lakhs .
- Liquid assets and or availability of credit facilities usually 30% of the amount of contract i.e 25.96 lakhs.
- The tenderer should have executed in any one year the following minimum quantities of works usually 80% of the annual requirement i.e 450 mm dia DI pipeline - 800 rmt, (OR Higher dia and length.)
- Assessed Available tender capacity (A*N*2.5-B).
- Each tenderer should further demonstrate (a) availability by owning at least 50% of the required / specified key and critical equipment for this work and (b) the remaining 50% can be deployed on lease/hire basis for all works provided, the relevant documents (commitment

agreements etc) for availability for this work are to be furnished especially for the Crane.

- Liquid assets and /or availability of credit facilities of no less than Rs. 20.32 lakhs credit lines/ letter of credit/certificates from banks for meeting the fund requirement etc. (usually the equivalent of the estimated cash flow for three months in the peak construction period)
- The successful bidder would be required to give performance **bank guarantee of 3%** of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
- Refer Annexure (A) enclosed along for jurisdictions of the courts and safety measures to be taken while executing the works as per letter No.BWSSB/EIC/CE(P)/0027/16-17 dt:10.04.2017.
- Applications / requisitions from joint venture Firms are not acceptable.
