For and on behalf of the Bangalore Water Supply and Sewerage Board, **SHORT TERM PERCENTAGE/ ITEMWAR TENDER** is invited through e-procurement process with tender procedure in line with Rule 28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (West), Vijayanagar 2nd Stage, Hampi Nagar, (RPC Layout) Bangalore - 560 040 for the following work from registered Agencies of appropriate class as indicated against each work of **BWSSB/KUWSDB/KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid GST registration, The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

- 1) Credit Card (Online Payment) 2) Direct Debit Using internet Banking (Online Payment) 3) Remittance at the Bank Counter - Challan (Offline Payment) 4) NEFT (National Electronic fund transfer) (office payment). The details regarding their capability to undertake the tender (as detailed in IFT Clause 4) and the price tender shall be uploaded in the website. Technical details will be opened on the date and time mentioned in IFT clause 6 and evaluated. The price tender of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderer to qualify for award of the contract.

the bid document in to electronic tender on the website. Scanned document those are required to be furnished as per section 2,3 & 4 of the bid document shall be submitted through e- procurement.

- The Tender processing fee once paid will not be refunded.
- The last date and time for Receipt of tenders will be on **04.05.2021 upto 16.00 Hrs** and date of opening of tender will be **on 05.05.2021 after 16.30Hrs**.



The Eligibility criterion for the above works allotted for General category is as follows:

- Contractors should have Civil Contractor registration in BWSSB or KPWD/KUWSDB, etc Those who do not have BWSSB registration can also participate in the tender, provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
 - Form of tender is mandatory to be uploaded in e-procurement portal.
 - Assessed available tender capacity = $(A*N*2.5 - B)$ should be greater than the amount put to tender.
 - The Tendered should have satisfactorily completed one similar work to an extent of 50% of the cost of the work (50% of the amount put to tender).
 - Third Party will be nominated by BWSSB
 - The successful bidder would be required to give performance bank guarantee of 3% of the contract amount plus additional security for unbalanced bid amount(50% of unbalanced amount) from a Nationalized/ Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period as per ,GO No.FD675 Exp-12/2020, Bengaluru dated:22.12.2020
1. The tender is based on single Cover System.
 2. Applications / requisitions from joint venture Firms are not acceptable.
 3. Bangalore Water Supply and Sewerage Board (BWSSB) reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.
 4. For any additional information regarding the above tender, the firms who are interested to quote, may contact office of the undersigned at the office address given below on all working days during office hours (10:30 hours to 17:00 hours).
 5. List of document to support qualification of bidder is to be uploaded to the e-procurement website www.eproc.karnataka.gov.in .
 6. Bidders shall submit offers that comply with the requirements of the bid document, including the basic technical design as indicated in the drawing and specifications. Alternatives will not be considered. The attention of the bidders is drawn to clause 23 regarding the rejection of the bids, which are not substantially responsive to the requirement of the bid document.
 7. Other details can be seen in the tender documents.
 8. The works to be executed in accordance with the contract document and carry out all the works as per the guidelines in the "Draft Safety Manual for construction and maintenance of UGD lines and septic tanks in Urban Areas-2013". Any lapses following the safety guidelines, the contractor /agency/firm will be held solely responsible.
 9. Cutting Road Surfaces for pipe line trenches should be executed using machineries only.
