The Bidder can download the E-procurement document using his user ID-Password, by accessing Karnataka Govt. website and by clicking on e-procurement portal which will link to www.eproc.Karnataka.gov.in where electronic tender form is provided. Additional information related to e-procurement process can be obtained through the above mentioned website. The electronic tender comprising Technical and Financial bids will be operated as **Single Cover System**.
3. Tenders must accompanied by Earnest Money Deposit specified for the work in the Table below. Earnest Money Deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 45 days beyond the validity of the tender.

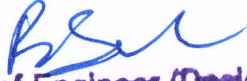

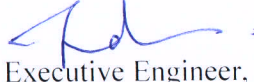
5. The last date for submission of completed tender document is 09-06-2021 to 16:00 hrs. The bids will be opened on 11-06-2021 at 11.30 hrs. If the bid-opening day remains as public holiday, Bids will be opened on the next working day at the original stipulated time.
6. EMD can be paid through OTC, NEFT, and DEBIT CARD & CREDIT CARD through E – Procurement only. The value of the Bid Security / EMD is as mentioned in the table above in column no 4.
7. Bidders can access tender documents from the website and upload the required details; those are mentioned in different sections in the bid document in to electronic tender box on the website. Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e- procurement in **PDF** format for clear vision.

9. The successful bidder would be required to give performance bank guarantee of 5% of the contract amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
