



1. The Executive Engineer, Quality Assurance Division, BWSSB invites tenders from eligible tenderers, for the work detailed in the Table below. The tenderers may submit tenders for any or all of the works given in the Table. **Two Cover Tender procedure as per Rule 28 of the KTPP Act shall be followed. The Tenders are required to submit their EMD, technical offer and financial offer and the details of their capability to undertake the tender (as detailed in ITT Clause 3 and section 2(a) and section (4) in Karnataka e-procurement portal. The price tender will be opened only if the Tenderer is found to be qualified to execute the tendered work. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.**
2. Tender documents can be view/download from e-Procurement portal from 26-07-2021 to 09-08-2021. Interested Tenderers may obtain further information at the address mentioned below.
3. The Tenderers can download the bid document using his user ID-Password by accessing Karnataka Govt. e-procurement website www.eproc.Karnataka.gov.in for electronic tender form. Additional information related to e-procurement process can be obtained through the above mentioned website. The electronic tender comprising Technical and Financial bids will be operated as **Two Cover System**.
4. Tenders must be accompanied by earnest money deposit specified for the work in the Table below. Earnest money deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 45 days beyond the validity of the tender.

The Technical bids (cover one) will be opened 11-08-2021 at 15.00hrs and Financial bids of technically qualified tenderers (cover two) will be opened on 13-08-2021 15.00hrs. If the bid-opening day remains as public holiday, Bids will be opened on the next working day at the original stipulated time.
6. EMD can be paid through OTC, NEFT, and DEBIT CARD & CREDIT CARD through E-procurement only. The value of the Bid Security / EMD is as mentioned in the table above in column 4.
7. Tenderers can access tender documents from the website and upload the required details, those are mentioned in different sections in the bid document in to electronic tender box on the website. Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e-procurement in PDF format for clear vision.
8. The cost of the tender document once paid will not be refunded.
9. The successful Tenderers would be required to give **performance bank guarantee of 5%** of the contract amount plus **additional security for unbalanced bid amount from a Nationalized/Scheduled Indian Bank**, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.
10. Applications / requisitions from joint venture Firms are not acceptable.
11. Bangalore Water Supply and Sewerage Board reserve the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.
