For and on behalf of the Bangalore Water Supply and Sewerage Board, **ITEMWAR TENDER** is invited through e-procurement process with tender procedure online with Rule 28 of the KTPP Act by the Executive Engineer, Water Supply and Sanitary Division (North), Pinakini Bhavan, Doddaballapur Road, Yelahanka New Town. Bangalore-560055 for the. Work of providing under ground drainage facilities to Rajiv Gandhi N T I layout Phase - II including crossing of railway track by trenchless technology under N3 Sub division from registered Agencies of appropriate class as indicated against each work of **BWSSB/ KUWSDB/ KPWD**, etc. Who are having adequate financial resources, past experience in similar nature of work possessing valid VAT registration. The Board keeps the right of acceptance or rejection of any tender without assigning any reasons.

The Tenderers are required to pay the Earnest Money Deposit only through e-procurement portal only using any of the four modes.

1. (1)Credit Card (Online Payment) 2) Direct Debit Using Internet Banking (Online Payment) 3) Remittance at the Bank Counter - Challan (Offline Payment) (4) NEFT (Offline payment). The details regarding their capability to undertake the tender (as detailed in ITT Clause 4) and the tender shall be uploaded in the website. Tenders will be opened on the date and time mentioned in ITT clause 5 and evaluated. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e- procurement.
5. The Tender processing fee once paid will not be refunded.
6. The Last date and time for Receipt of tenders will be on 09/08/2021 upto 15.00 Hrs and the date of opening of tender will be on 10/08/2021 after 16.00 Hrs.

The Eligibility criterion for the above works is as follows:

- The tender is based on Two Cover System
- Contractors should have registration in BWSSB or KPWD / KUWSDB, etc Those who does not have BWSSB registration can also participate in the tender provided they should get registered in the Board in case the tender is awarded before the issue of Work Order.
- The Tenderer Should have in the last 5 years period achieved in at least two financial years an average annual financial turn over of rupees not less than the estimated cost under this contract i.e Rs.98.89 lakhs
- The tenderer should have satisfactorily completed one similar work to an extent of 50% of the cost of the work. i.e Rs.49.45 lakhs .
- Liquid assets and or availability of credit facilities usually 30% of the amount of contract i.e 29.67 lakhs.

- The tenderer should have executed in any one year the following ~~minimum quantities of works usually 80% of the annual requirement~~ i.e 300 mm dia RCC NP3 Class pipeline – 1367.84 rmt,(300mm dia RCC NP3 Class and higher dia & higher length). And 230 mm dia SW pipeline – 347.2 rmt,(230mm dia SW and higher dia & higher length).
- Assessed Available tender capacity (A*N*2.5-B).
- Each tenderer should further demonstrate (a) availability by owning at least 50% of the required / specified key and critical equipment for this work and (b) the remaining 50% can be deployed on lease/hire basis for all works provided, the relevant documents (commitment agreements etc) for availability for this work are to be furnished especially for the Crane.
- The successful bidder would be required to give performance **bank guarantee of 3%** of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified, towards guarantee for completion of work within the stipulated period.

- Applications / requisitions from joint venture Firms are not acceptable.
