The Bangalore Water Supply and Sewerage Board through Government of Karnataka (GOK) has received a loan from Japan International Cooperation Agency (JICA) towards the cost of Bengaluru Water Supply & Sewerage Project – (Phase 3). It is intended that part of the proceeds of this loan will be applied to eligible payments under the Contract for Sewerage Facilities to 110 Villages: Design, Engineering Construction and Commissioning of Sewage Treatment Plants and Intermediate Sewage Pumping Stations with Operation & Maintenance thereof for Seven Years [Works-A] and Procurement and Construction of Main Sewers including Manholes in Bytrayanapura (Hebbal Catchment) [Works - B] (Contract Package No. BWSSP (III) /JICA/CP-25).
2. Bidding will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans, and is open to all Bidders from eligible source countries, as defined in the Loan Agreement. The original Bid Security shall be submitted in an envelope having inscription of project name, package name and Bidder information and shall be submitted along with the Technical Bid envelope to the address/time and date given as per Bid Data Sheet (BDS).
3. The Bangalore Water Supply and Sewerage Board (BWSSB) now invites sealed Bids from eligible Bidders for Sewerage Facilities to 110 Villages: Design, Engineering Construction and Commissioning of Sewage Treatment Plants and Intermediate Sewage Pumping Stations with Operation & Maintenance thereof for Seven Years [Works-A] and Procurement and Construction of Main Sewers including Manholes in Bytrayanapura (Hebbal Catchment) [Works-B] (Contract Package No. BWSSP (III) /JICA/CP-25) hereafter referred to as “the Works”. International Competitive Bidding (ICB) will be conducted in accordance with JICA's “Single-Stage Two Envelope” Bidding Procedure.

The procurement of the similar type of works is intended to be done in shell of one Group of the contract packages under the project.

In consideration of possible formation, in general, of in-compatible alliance among the various bidders and apprehension on the part of the Employer, due to non-performance or under performance of the contract by the successful bidder/bidders after award of the contract, it is determined by the Employer that at the most only one contract will be awarded to one bidder under a group of contract comprising similar type of works, in a group of works as indicted one above.

The following two contract packages form the one group:

Contract Package – BWSSP(III)/JICA/CP26

Sewerage Facilities to 110 Villages: Design, Engineering Construction and Commissioning of Sewage Treatment Plants and Intermediate Sewage Pumping Stations with Operation & Maintenance thereof for Seven Years [Works - A]

Procurement and Construction of Main Sewers including Manholes in Mahadevpura and Bommanahalli Zones (K& C Valley Catchment)[Works - B]

Based on the experience of earlier project, now therefore the Employer – BWSSB, intends to award the different contracts of the same group, to different bidders qualified to perform the contract.

This is with the intention not only to augment the conscientious competition among the bidders and also to safeguard against breach of the performance and/ or under performance of the contract by a single bidder who, in case otherwise, has been awarded multiple or all contracts of a one group of contracts. The policy is being adopted by the Employer to mitigate the risk, to some extent, of affecting the progress of the execution of the projects in case dispute, if any, arises with the contractor who has been awarded multiple contracts of one group of Contract packages.

For the preset bidding documents two works' packages namely Contract Packages CP-26 and CP-27 falls under same group of Contract packages of sewage works.

As per JICA instruction in this matter in case either of Contract Packages is awarded to one bidder who is either a single entity or a Joint Venture of partners then from remaining of the group contracts none will be recommended for awarded of that contract.

For example, if a single entity or a JV firm comprising Company –A and Company B is already awarded with one contract of the group then one more contract of same group shall not be to the same single entity or to the same JV or to any other JV in which either Company A or Company B is one of the partners in that JV.

This could be understandable from the illustration as below:

In the below illustration X and Y are single entity bidders, while A + B or C + D are typical combination of JV partners:

1.2 Economic Evaluation

Any adjustments in price that result from the procedures outlined below shall be added, for purposes of comparative evaluation only, to arrive at an "Evaluated Bid Price." Bid Prices quoted by Bidders shall remain unaltered.

In addition to the criteria listed in ITB 38.2 (a) – (c) the following criteria shall apply.

1.2.1 Quantifiable nonmaterial nonconformities

Pursuant to ITB 34.3 and ITB 38.2 (d), the cost of all quantifiable nonmaterial nonconformities or omissions (minor omissions or missing items) shall be evaluated. The Employer will make its own assessment of the cost of any nonmaterial nonconformities and omissions for the purpose of ensuring fair comparison of Bids.

1.2.3 The Price Bid evaluation will be done inclusive of all Taxes and Duties.

Under Sub-Clause 38.2 of ITB, the following Methodology will be adopted to find the lowest evaluated bid:

a) Determination/Evaluation of Works / Capital Cost

Total cost of the WORKS A (Sewage treatment plant& ISPS) will be evaluated based on technical requirements as well as **price quoted including all taxes and duties** by each bidder. The Schedule-8: Recommended Spares and Provisional sum shall not be considered for evaluation of the bids.

b) Determination/Evaluation of O&M Cost of Plant

The procedure for evaluation of Operation Cost of Plant is as follows,

- Price correction for arithmetic errors in accordance with ITB 36.1
- The Bidder shall be asked to provide in Technical Bid for the materials and electrical energy consumptions such as rate of consumption of chemicals, electrical energy consumption (in KWH) etc.
- In Price Bid (Volume III) the quantities of chemicals consumption shall be the same as quantities of chemicals consumption submitted in Technical Bid (**Volume 1, Schedule of Guarantee (Works-A) of Section – IV**) . In case, the quantities of chemical consumption provided in price bid are different than in the Technical bid, then the corrections/adjustments shall be made during price bid evaluation to arrive at the corrected O&M cost by considering quantities of Chemical Consumptions as per Bidder Technical Bid (Volume 1, Schedule of Guarantee (Works-A) of Section – IV) in accordance with ITB 34.3.
- The Bidder shall quote quantities of chemicals consumption as submitted in (Volume 1, Schedule of Guarantee (Works-A) of Section – IV) for each year of the O & M period of seven (7) years. (Ref. Price Schedule-6 of Works-A, Volume 3 of Price bid).

- If there is any inconsistency in the chemical quantities observed in the price bid, necessary correction shall be carried out by the Employer based on the accepted technical bid.
